**Please note: Incomes indicated on the free and reduced price eligibility scales are maximum amounts.**

If your household income is **ABOVE** the reduced price eligibility scale you may complete your form with N/A (Non-Applicable) in the section regarding income.

If your household income is **at or BELOW** the reduced price eligibility scale please provide details of your income on the form. It will add our district in receiving additional funding from the state.
