STADIUM RULES

1. No metal cleats.
2. No gum, sunflower seeds, shelled peanuts, popcorn, tobacco products on the field/ track in stadium.
3. All teams must pick up after the contest. Please put all trash, tape, cups etc. in barrels.
4. Locker rooms will be provided at your request. Locker rooms will be inspected with visiting coach before and after the game.
5. The site supervisor will inspect the facility and all equipment used at the end of the event. If there are any damages, the using organization will be billed for the replacement cost.
6. The District will manage all concessions.
7. No tobacco use (smoking or chewing) on school property.
8. No unauthorized motor vehicle (including bicycles and ATV'S).
9. No animals, except for service animals.
10. No bottles, glass containers, intoxicants, roller blades, skate boards, paint or anything that can penetrate or puncture the surface (i.e. tent spikes).
11. Only the School District's equipment (i.e., football chain and marker apparatus, hurdles) shall be used in the Stadium.
12. Water is the only beverage allowed within the track and turf area.
13. At no time are spectators allowed on the track or turf.
14. We reserve the right to remove anyone who demonstrates a negative behavior in the stands and towards the field play.
15. Music will be provided by CCS unless approved 48 hours in advance.
16. Organizers must provide the necessary medical staff and AED for all rentals.
